ZERUST[®]/EXCOR[®] Axxatec[™] 77C is a water-based liquid concentrate rust preventative designed to provide up to 3 months⁺ of temporary indoor storage, in-line production, and assembly protection. Furthermore, Axxatec[™] 77C provides ferrous and multimetal protection while also being yellow metal and galvanized compatible. However, it's not intended to be used on aluminum.

When applied and dried, it leaves a safe, thin, hazy protective coating. As a result, Axxatec[™] 77C coated and dried parts are safe to handle, and end users do not need to wear personal protective equipment such as a respirator, mask, or safety glasses, making it safer and more economical to use than solvent-based systems. Even though gloves are not mandatory, we recommend using clean gloves without lint or talc to keep metals free of contaminants. After allowing metals to completely dry, place them into ZERUST[®] Vapor Corrosion Inhibitor (VCI) film packaging products for a more robust solution that protects for years[‡] during indoor storage or challenging shipping conditions, such as ocean freight. Axxatec[™] 77C does not contain solvent or VOC, is non-flammable, complies with Global Automotive Declarable Substance, TSCA, ECHA SVHC, RoHS, and REACH requirements, and is environmentally friendly.

Operating Summary

- Dilute between 3 10% in water.
- Typical operating temperature: ≥72°F (22°C) in most operations.
- Deionized or reverse osmosis water is required for bath makeup and rinsing to improve bath life and reduce corrosion potential, as the product is not hard water compatible.
- Dry well after application.

Application Technologies

• Can be used in immersion, brush, or spray processes.

Product Removal

• Axxatec[™] 77C is designed to be left on the metal surface as a rust preventative product. However, it can be rinsed and removed from the metal surface with the use of a compatible ZERUST[®] AxxaWash[™] product, or contact your ZERUST[®]/EXCOR[®] account representative for more specific removal recommendations on your particular operation and conditions.

Product Control

- Spray application: do not reuse collected product from spray booths or drip pans.
- Immersion application: for extended dip tank use, please contact your dedicated ZERUST[®]/EXCOR[®] account representative for detailed information.
- Brush-on application: use a brush with nylon bristles. Decant into a smaller container. Do not reuse product. Do not contaminate the original product container with the brush.
